IMPACT OF COVID-19 IN VARIOUS SECTORS

ON GDP OF INDIA -

As per United Nation report, India's GDP growth for the current fiscal is expected to slow down to 4.8 per cent. It is a warning that the COVID-19 pandemic is expected to result in significant adverse economic impacts globally.

According to the UN 'Economic and Social Survey of Asia and the Pacific (ESCAP) 2020 COVID-19 is having far-reaching economic and social consequences for the region, with strong cross border Spill pill over effects through trade, tourism and financial linkages. Due to the COVID-19 pandemic, there is a significant impact on the global economies and the international financial markets.

ON ICAI -

Due to covid-19 outbreak ICAI has already been extended the date for all level of examination by three times, The Institute of Chartered Accountants of India (ICAI) has created the 100crores rupees for Scholarship to CA students. ICAI is taking various initiatives for the overall development of its students by helping them to widen their knowledge and molding them as world-class professionals. In this context, a Corpus fund of Rs.100 crore has been created and earmarked by ICAI to provide scholarships for the students who are pursuing the Chartered Accountancy Course and increase the beneficiaries gradually to strengthen the presence of the students.

ON GST -

GST collection is one of the prime source of revenue for the states and for central it is too a major source, that is seriously compromised in the month of April with several state governments reporting serious fall in collections that are as high as 80-90 per cent in some cases. That is so because due to lock down phase supply couldn't take place meanwhile no transactions happened in between of end of March to April and hence, there is a situation shortfall in levy and collection of taxes and as a result of it govt have been opened the liquor stores with 70% of MRP as cess charge and pay to the government. GST collections have been badly hit in hilly states that depend largely on tourism and hospitality for revenue.

ON STOCK MARKET -

According to Gaurav Garg, Head of Research at Capital Via Global Research, Investment Advisor the complete shutdown of the business has led with high fixed cost, high working capital, low liquidity. The market remaining under pressure. Not any other infectious disease outbreak has impacted the stock market as powerfully as the COVID-19 pandemic in 2020. Indian stock market has lost 26 per cent in dollar terms between February 1 and April 9, compared with a fall of 20 per cent and 14 per cent in the European and US markets. Emerging markets, reflected by the MSCI EM index, declined 15 per cent during the same period. India has eroded around 25% as per latest research commented by Edelweiss Securities.

Where China has been least affected, with just 3 per cent fall in the stock market between February 1,2020 and April 9, 2020, from where the virus originated.

ON PETROL, DIESEL AND ALCOHOL -

Due to corona impact govt hiked the rate of petrol and Diesel. Congress-ruled state hiked taxes on diesel and petrol by around Rs 2.2 per litre each on March 22, two days prior to the start of the nationwide lock down, and again raised the taxes by Rs 0.5-1.1 per litre later during the lock down.

Taxes on Fuel and alcohol are the crucial source of govt revenue. Sales tax/VAT on petroleum products are 15-20% of the state's own tax revenue (OTR) and approximately 10-15% of OTR comes from levies of taxes and cesses on alcohol for human consumption. Although since mar 16 crude prices have fallen by 32.5% but till 4th may petrol and diesel rates remain unchanged and suddenly on 4eth may diesel price rose by 11.4%.

FUND DISTRIBUTION -

For mounting the emergency response to reduce and limit the covid-19 impact GOI has announced a wide significant investment of RS 15000 crs. The sanctioned fund will be utilized for immediate covid-19 to emergency response (Approx. Rs 7774Crs.) and remaining amount for medium term support under MISSION MODE approach. This provision is made for curing Corona affected patients and strengthening the medical infra of country.
